## TREATMENT NOTICE

Dear customers, we inform you that Control Natural de Plagas Mediterraneo, S.L. will carry out biocide treatments in its facilities, which by the nature of the products used can cause discomfort or adverse health effects. Please carefully follow the recommendations and precautionary measures set out below to minimise these effects.

**ZONE TO TREAT:** Common areas and green areas.

Date: See the **Treatment Calendar for Adult Mosquito Control 2021 - below**

Start Time: 00: 30h End Time: 06: 00h

**OBJECT OF THE TREATMENT:** Disinsection treatment to control adult mosquitoes.

1. All the treatments carried out by Control Natural de Plagas Mediterraneo, S.L., are carried out by qualified and technicians authorised in the application of biocides.

2. All the products used by Control Natural de Plagas Mediterraneo, SL, are authorised for the use or treatment that we carry out, having a valid registration number for biocides in the Ministry of Health, social policy and equality or current registration number for pesticides in the Ministry of the Environment, Rural and Marine Affairs.

3. We remind you that before performing the treatments, Control Natural de Plagas Mediterraneo, S.L. performs an assessment of the pest to be treated and proposes the treatments, always prioritising the least aggressive methods for people and the environment (physical or biological methods), always limiting the use of chemical products to those cases in which other methods are insufficient to get proper control.

4. In choosing the product to be used, aspects of both hygienic safety (less toxicity for humans and non-target species) and environmental (selectivity for the target species, less persistence in the environment), as well as the moment are taken into account. and place of treatment (moment of greatest vulnerability of the pest, product safety periods), in order to minimise the possible risks derived from treatments in both indoor and outdoor environments.

5. We attach to this communication the safety sheets of the products used, as well as a sheet of recommendations to follow, both prior to the treatments, as well as during and after them, recommendations that must be transmitted to all neighbours

that could be affected in the field of treatment.

Nor is it permitted the presence of animals during application of biocides.</p> <p>Not be permitted the transit of persons, animals or vehicles during the course of treatment.</p> | <p>Do not use the treated areas, as well as those who have been affected until after at least 12 Hours after the treatment. These areas have been reported in previous form.</p> <p>If treatment has been conducted in inland areas, before using those areas or proceed to clean them, you should ventilate each treated area. Ventilation is always made after the expiry of the security.</p> |

In order for the applications to be as effective as possible, the treatment nights must be suspended in the green areas subject to control, otherwise, the company cannot guarantee their complete effectiveness, nor access to all the programmed areas, since the land must be dry to be able to be traveled, and the product must remain in the vegetation throughout the night.


